Recent News from OCC and the VC CORE

Two Rapid RFA Funding Opportunities!

Just when we thought we were out, RFA season pulled us back in with two urgent opportunities, announced last week.

RFA PDFs are attached in the email with this newsletter and linked in our Opportunities table.

OCC Controlled Substances RFA (due date 12/12/2022):

VA is seeking modifications to 38 USC 1730C that would authorize covered VA health care professionals to prescribe controlled substance treatments through telehealth, in the absence of a prior in-person medical evaluation, when deemed medically necessary and in accordance with the standard of care.

Soliciting Priority Questions and Ideas for Caregiver Research

The Elizabeth Dole Center for Veteran and Caregiver Research is looking to help the VA develop a research agenda focused on caregiving. This agenda would identify gaps in our knowledge, policies, and programs that can best support caregivers of Veterans. As such, the Office of Connected Care is releasing a time-sensitive Request for Applications to conduct an evaluation of telehealth prescribing practices for controlled substances. Findings from this work will be used to inform the development of national standard requirements for VA health care providers when prescribing controlled substances through telehealth. This evaluation will require rapid turn-around and close communication with OCC leadership as VA seeks legal authority from Congress to implement this potential change in practice.

Shorter-term priorities for this work include understanding, retrospectively, tele-prescribing patterns for controlled substances. Longer-term priorities include understanding, prospectively, the outcomes associated with modifications to 38 USC 1730C. Specific objectives are included in the RFA PDF.

OCC is soliciting proposals with a budget of up to \$250k for FY23. The deadline for applications is **December 12, 2022**, awardees should expect to be notified, funded, and able to begin work on a quick turnaround. Please see the PDF for all relevant details!

TeleHealth Research and Innovation for Veterans with Cancer (THRIVE) Pilot Project RFA:

The THRIVE team are requesting proposals for pilot studies that are focused on virtual care modalities for Veterans with cancer, with specific interests in social determinants of telehealth and health equity. Pilot studies can be at the facility, VISN or national level. They may be interventional or observational. The deadline for applications is **January 15, 2023**.
