The VA Informatics and Computing Infrastructure (VINCI) is a major informatics initiative of the Department of Veterans Affairs (VA) that provides a secure, central analytic platform for performing research and supporting clinical operations activities. It is a partnership between the VA Office of Information Technology (OI&T) and the Veterans Health Administration Office of Research and Development (VHA ORD). VINCI includes a cluster of servers for securely hosting suites of databases integrated from select national VA data sources.



VINCI has data on more than <u>22 million patients</u> receiving care at over 1,400 medical centers, outpatient clinics, nursing homes, and domiciliaries. Most data originates from the extensively used Veterans Health Information Systems and Technology Architecture (VistA), the VA electronic medical record system.
