**RFA to Understand and Address American Indian and Alaska Native Telehealth Experience**

OCC is seeking a team of investigators to conduct a comprehensive evaluation to better understand telehealth utilization, experiences and outcomes among Veteran telehealth users and non-users who identify as American Indian and Alaska Native. The deadline for applications is Monday, **December 11th at 11:59 PM EST**. OCC and other program office liaisons will host an optional [Office Hours Q&A session](#). **Reminder: Request Portal for Letters of Support from the Office of Connected Care**

VC CORE recently collaborated with the Office of Connected Care Telehealth Services team to create a [submission portal for Letter of Support requests](#). A product of years of successful partnership with the research community, OCC advocated for this channel in the hopes of simplifying the process of obtaining letters of support for investigators and their office alike. Investigators begin by inputting basic information about their proposed studies, including the primary technology of focus and type(s) of support requested. The portal then routes the request to appropriate subject matter expert for review and generates a draft letter to be refined by the investigator for signature, pending review. OCC asks that requests be submitted with ~4 weeks’ notice before grant deadlines, whenever possible, to allow for adequate review and consideration.

We have received our first few requests through this portal, and while the process and output are still works in progress, it has successfully created connections for a few intrepid early adopters.
