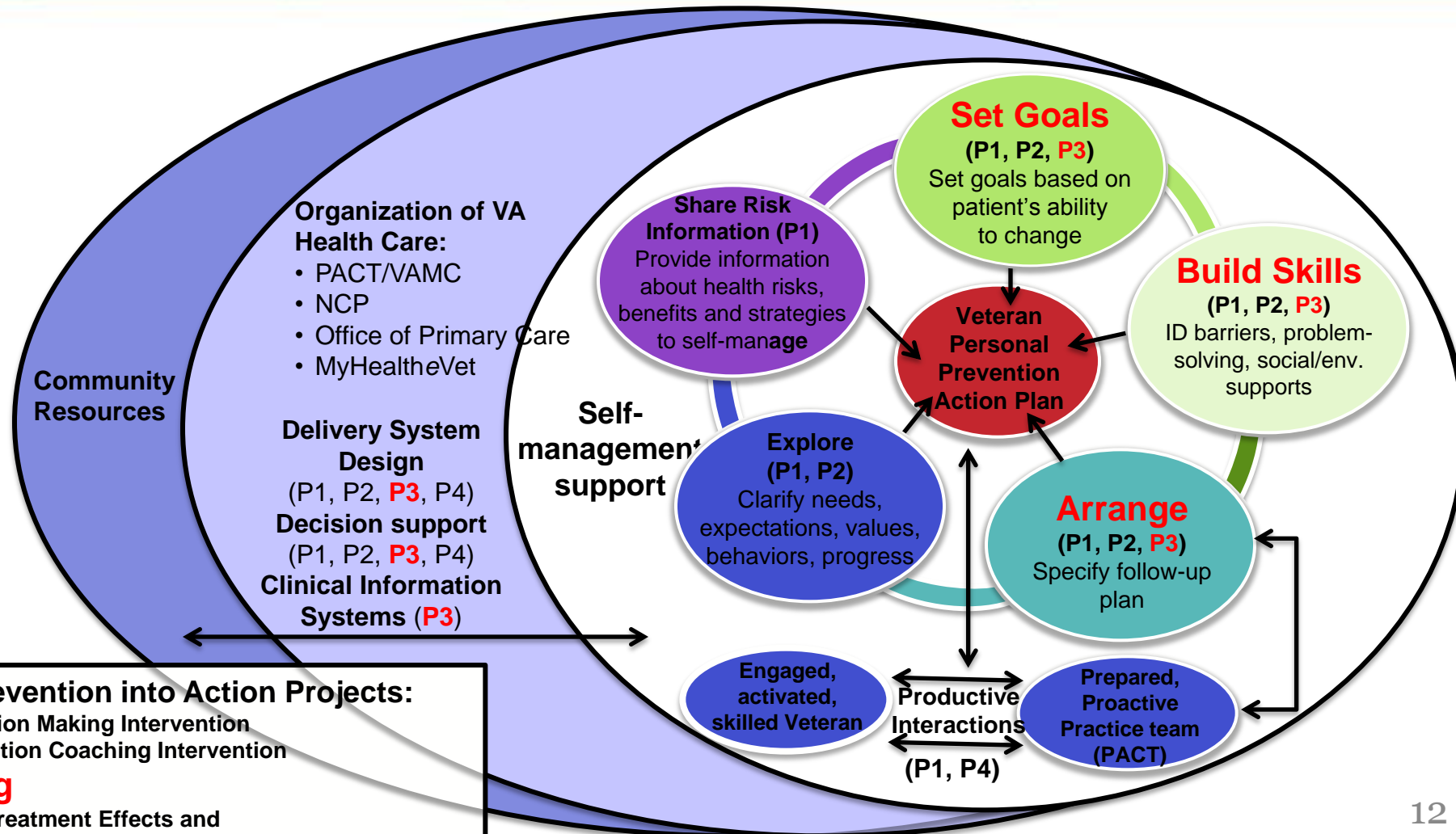

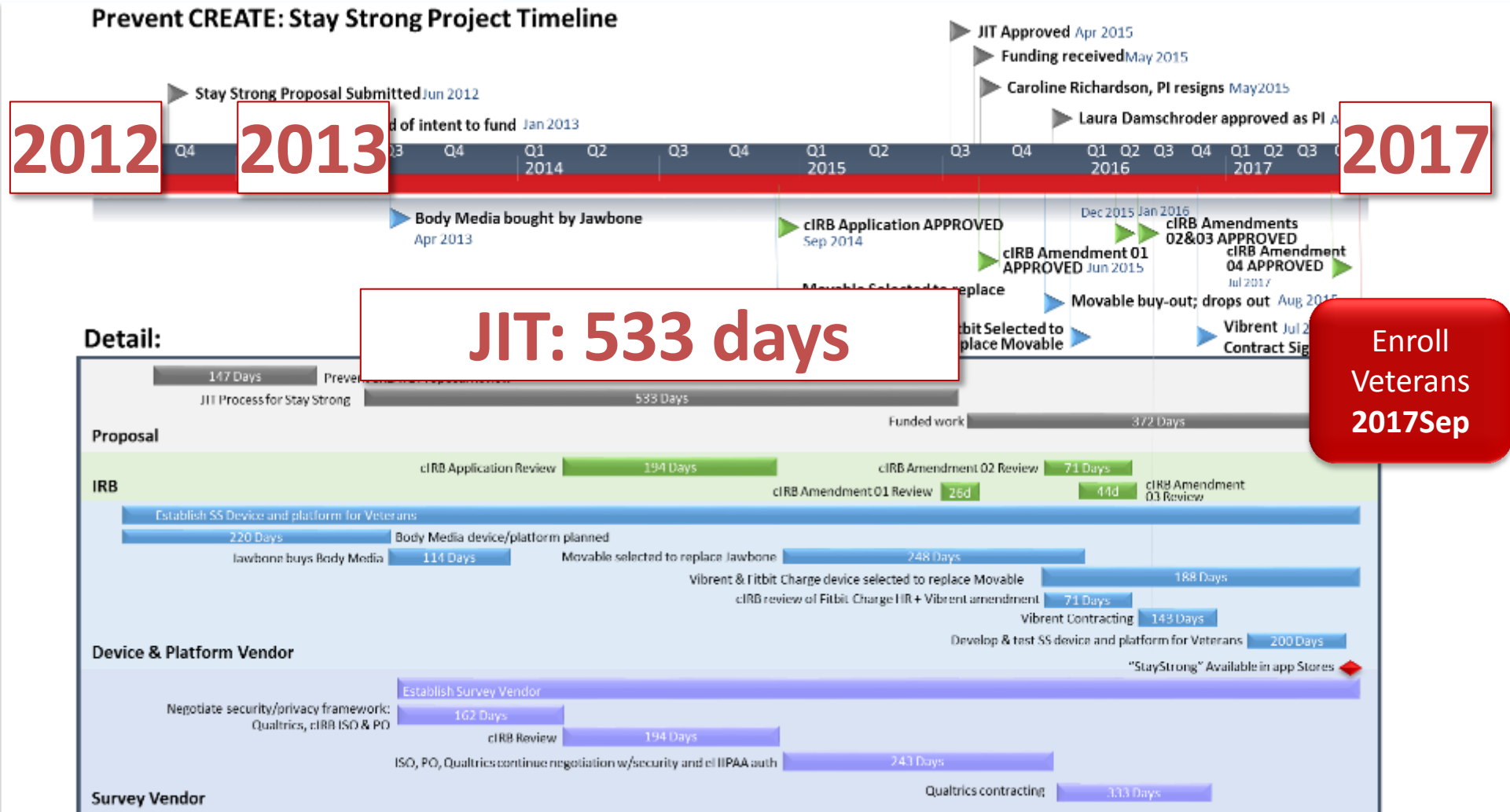

# Disclosure & Privacy Protections

- **Informed Consent**

- Full disclosure

- List of devices with full descriptions of each
    - Data syncing via what technologies (e.g., Fibt Connect software, Vibrent app, Fitbit servers)
    - Electronic data storage: outside the VA firewall
      - Multiple Locations: Each is described
    - Transmission of data
    - Technical issues
    - Risks
    - Protections in place

- **HIPAA Authorization**

(Copy of materials available upon request)

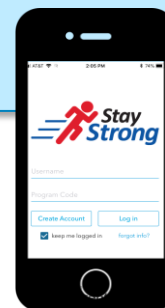

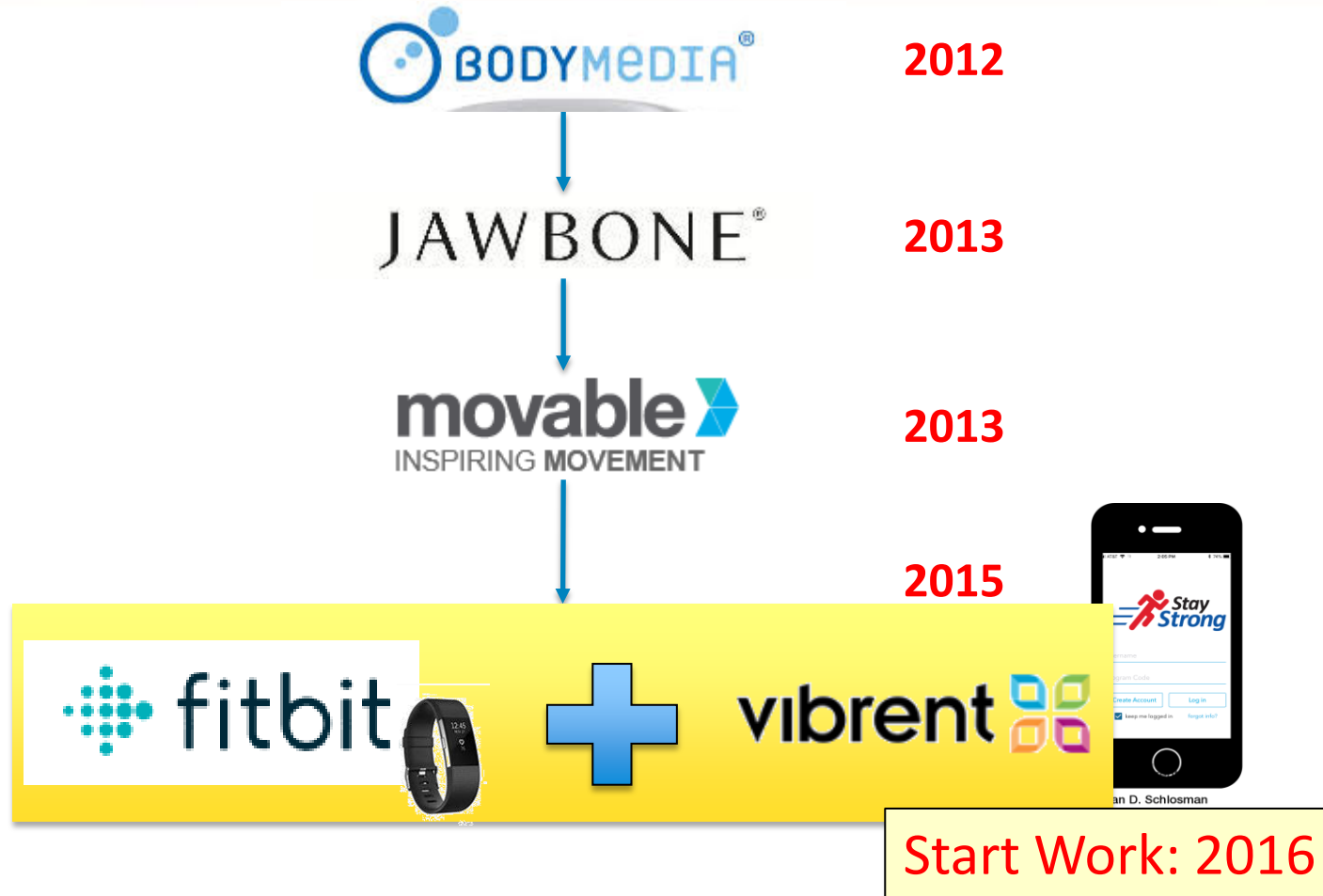

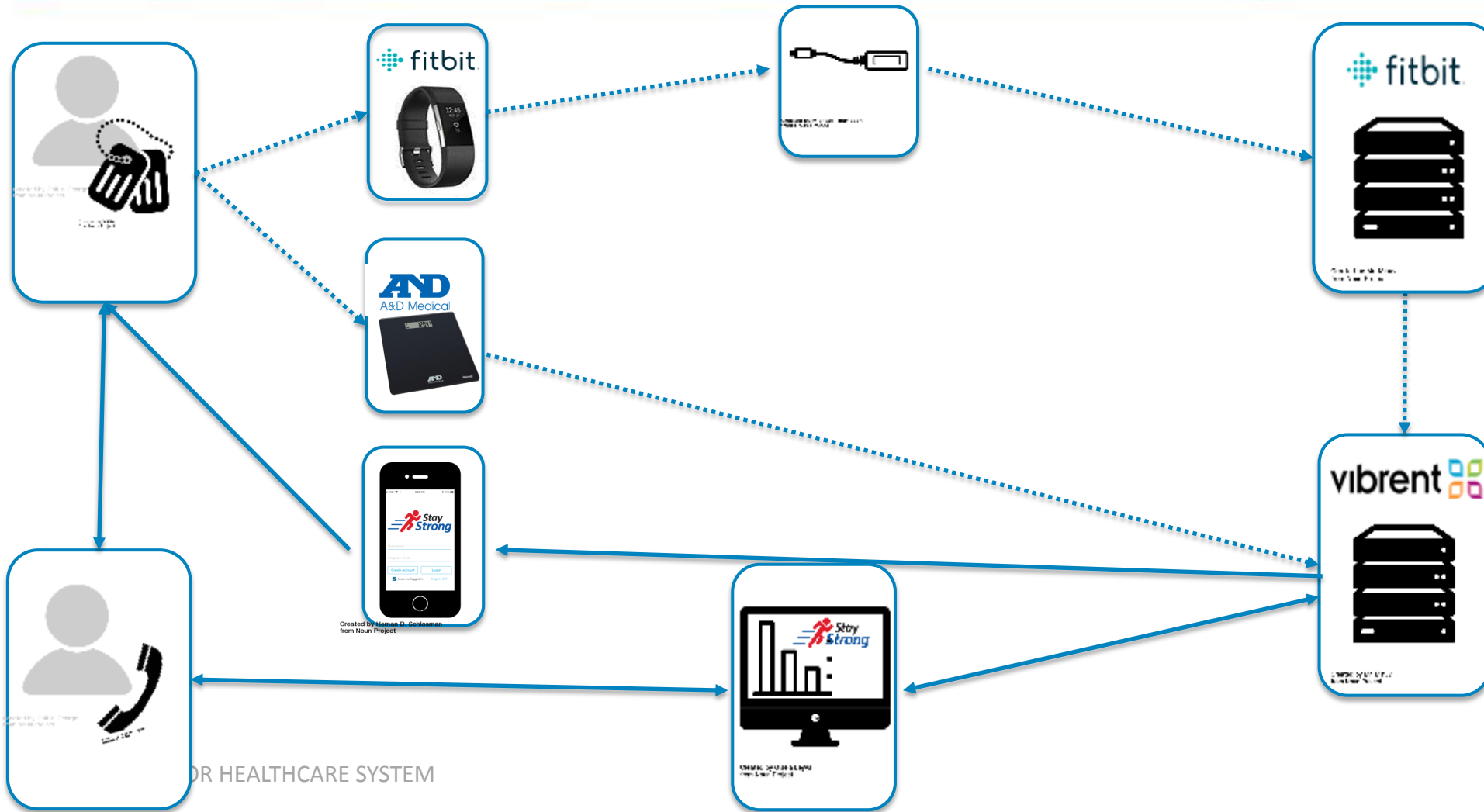

# Market Place v Research Pace

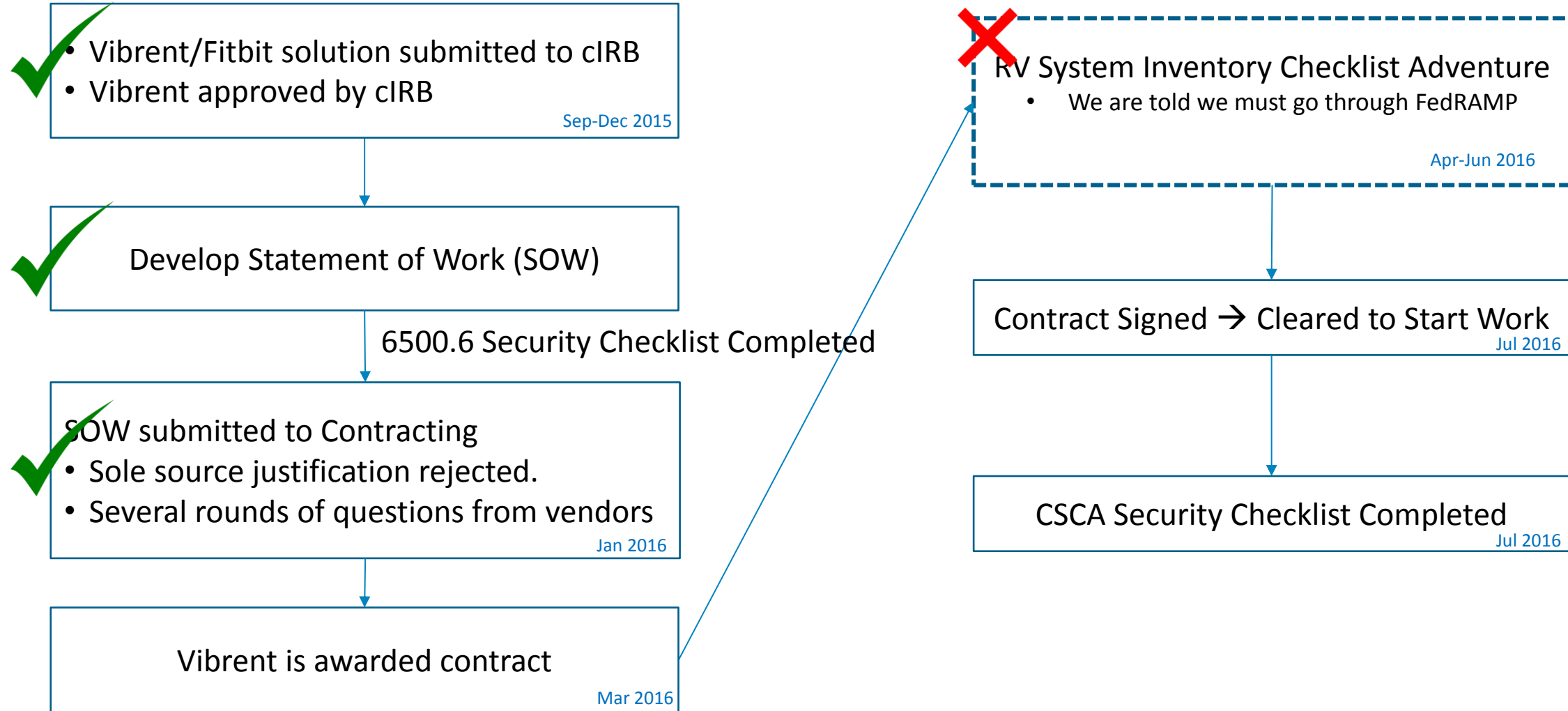

# On-boarding Vendor: Mobile Technology and More



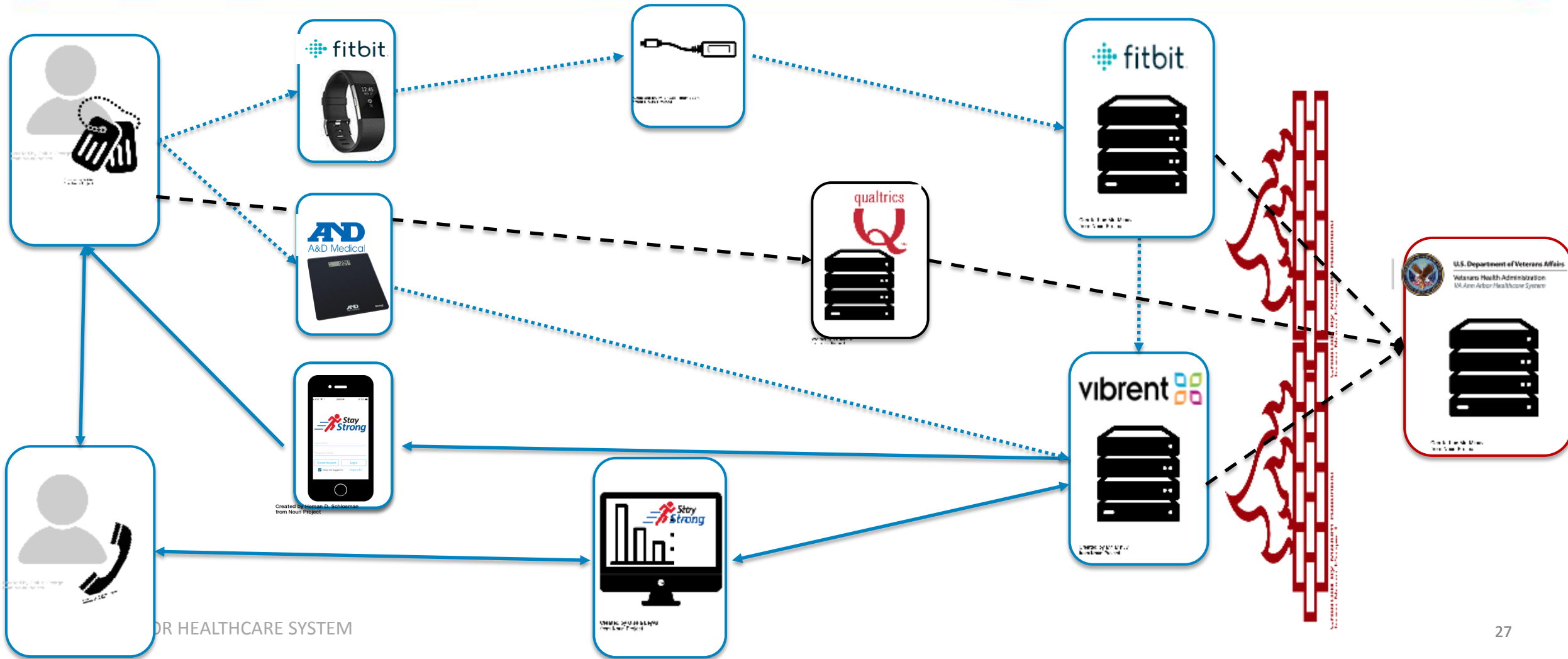
## Considerations for Mobile Device Vendor Selection...

- **What is a mobile device/how defined?**
  - Laptops, USB/flash, smartphones, tablets
- **Questions to ask yourself:**
  - Sensitivity of responses being solicited?
  - Equipment needed: VA, affiliate, subject owned?

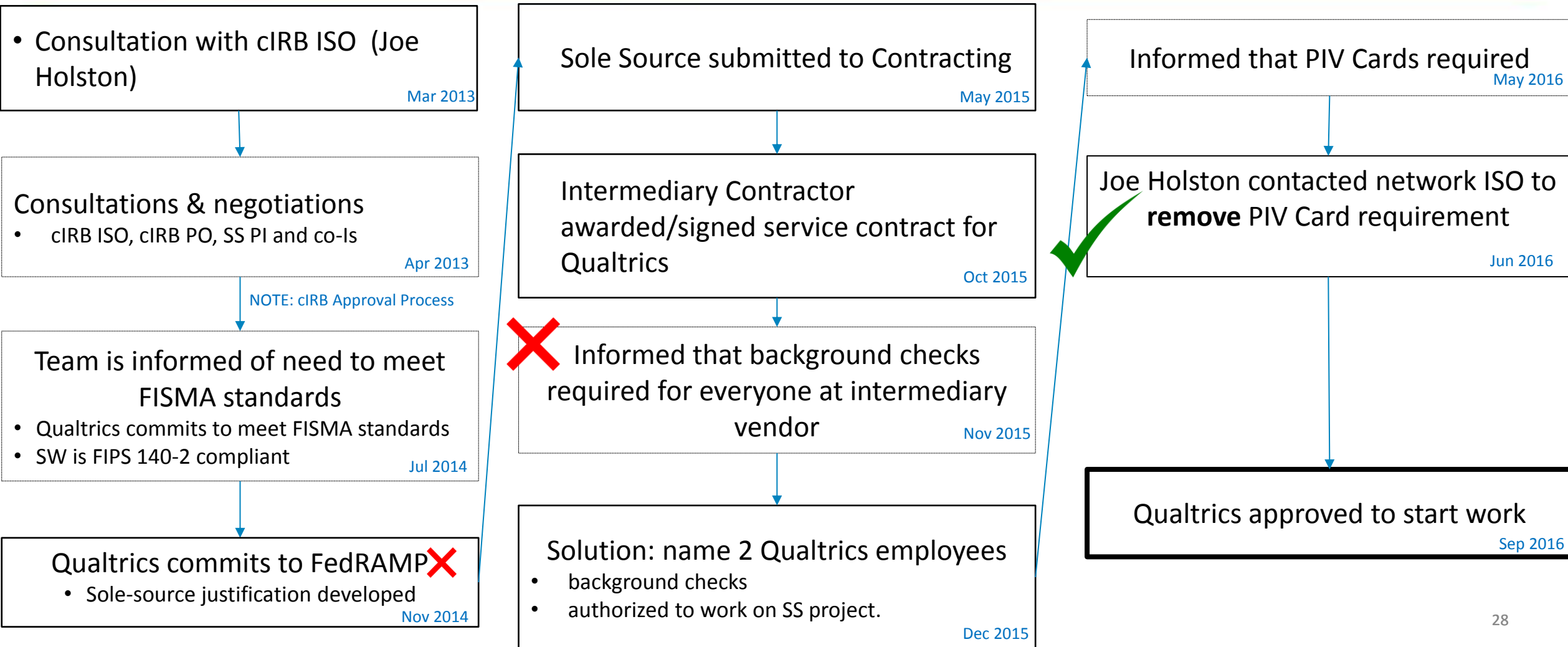
## Regulation of Mobile Devices in VA Research...

- **Policies that guide our thinking when planning for use of mobile devices:**
  - VA HB 6500
  - VHA HB 7002
- **Network Access, VA Data, Encryption**
- **Inventory, Data Storage and Destruction**

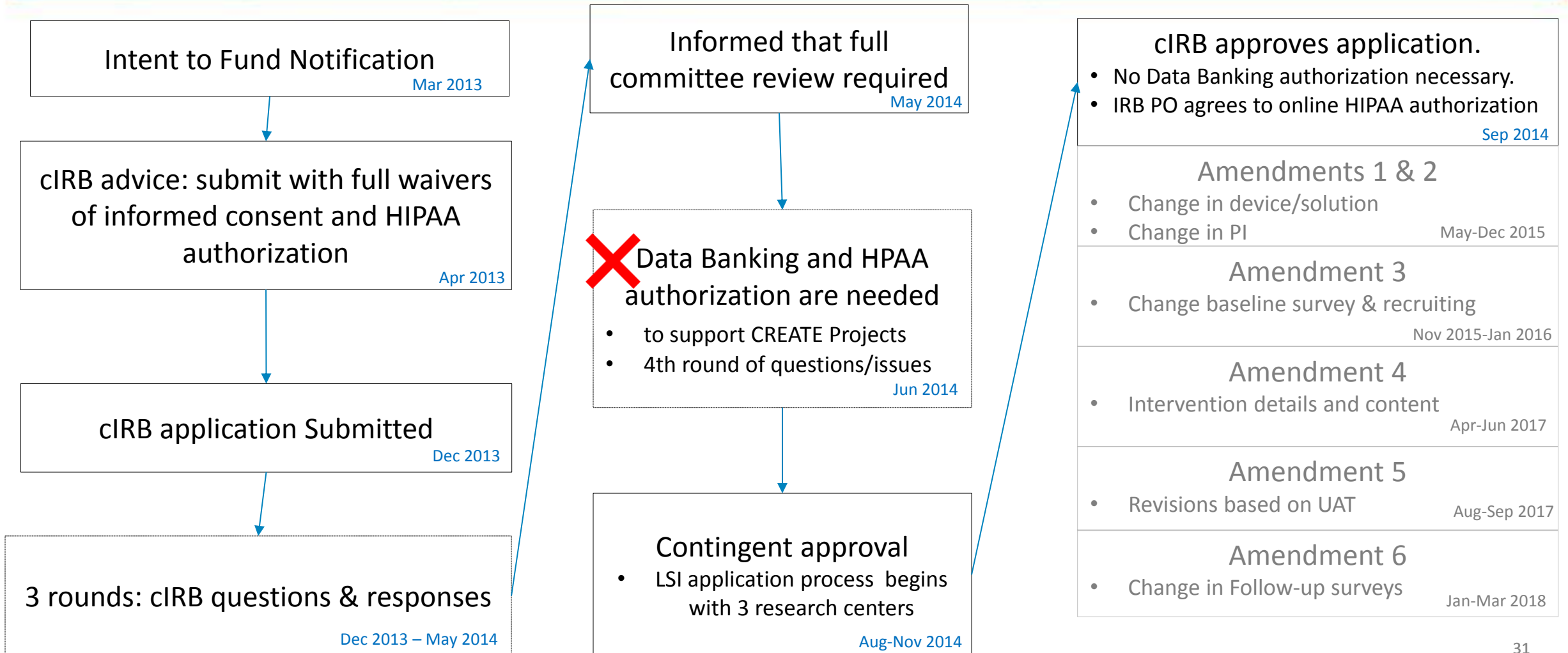
# Considerations When Evaluating Technologies...

- **Method of survey: how are users providing responses?**
- **Data class?**
  - de-identified
  - Coded
  - consented
- **Data Sensitivity?**
- **Privacy and data protection requirements as mandated by policy?**
- **Prior vetting?**
  - Service Catalogue
  - FedRAMP, etc

# Contracting & Purchasing

- **Vendors MUST be in “SAM” system**
  - System for Award Management
  - Get “solid” representative from the Vendor before contracting
- **Service v “Goods” contracts**
  - Be careful to specify in your Budget Justification
    - TYPE of contract
  - Blanket purchase agreements
- **Work with your local contracting officer representatives**
  - And get “checklist” of process AHEAD of time
  - Research Acquisition Center: South Atlantic Office (Pittsburgh, PA)
    - Research focused

- **General policy requirements for the use of technology in research**
- **ISO role on local IRBs**
- **IRB technology review and approval**
