1. Feasibility Assessment

- A Feasibility Assessment is a FREE VINCI service and is done prior to starting a protocol or study
- It is for determining if enough patients exist to conduct the study you want
- To request a Feasibility Assessment, send the following to <u>VINCI@va.gov</u>:
 - Put "Feasibility Assessment" in the email Subject line
 - Primary Investigator Name
 - Phone number and email address



1. Feasibility Assessment

- Inclusion/exclusion criteria
 - Location nationwide or specific location(s)
 - Time frame
 - Age/gender/other limitation
 - **Diagnosis ICD9/10 codes** Note: VA has used ICD10 codes since October 2015. If time frame exceeds 8 years, please provide both.
 - Procedures CPT codes or/and ICD-PC
 - Lab tests topography, units, range
 - Medications list of all generic and brand names, strength and route of administration

3a. Institutional Review Board (IRB) Letter

Prior to IRB submission, use VA Electronic Determination Aid (VAEDA). This is a regulatory decision support tool designed to help standardize the process by which VA makes preliminary project determinations of "not-research" vs "research that meets the definition of the common rule (38 CFR 16)."

3a. Institutional Review Board (IRB) Letter

- Generally, you will need an IRB Letter from each location where an investigator is involved
- It can come from the Central IRB, local VAMC, or University Affiliate
- Use the VA Innovation and Research Review System (VAIRRS) to submit your IRB request. Contact your local IRB or Research Office for access as it is location specific.
- Use <u>VINCI Description for IRBs</u> and <u>VINCI</u> <u>Information Security Description</u> in IRB request

- DART is VINCI's <u>Data Access Request Tracker</u> online application used by National Data Systems (NDS) and other data stewards to approve access to various data sources including CDW/VINCI data
- Collects study information and documentation via a 4-screen "Wizard"
- Determines required documentation based on Wizard entries
- Distributes the request to approving authorities who approve online

NDS cannot approve a research request that would include disclosing data requested through DART to entities outside of VHA unless the disclosure complies with VHA Privacy Office and Office of Research and Development (ORD) policy. ORD policy requires VHA research investigators to apply data use agreements (DUAs) when transferring research data external to VHA.

For example:

The HIPAA Privacy Rule permits the transfer of Limited Data Sets for research purposes, without obtaining an Authorization or documentation of Waiver of Authorization with a DUA.

If "finder" files are to be sent out to Federal or state agencies for the purpose of a Federal or state agency disclosing information on the individual back to VA per SOR 34VA12, a DUA between the PI and the external agency must be submitted with the DART application.






8. VINCI Provisioning
