The third meeting of CA-DRE's Veteran Engagement Panel was also its largest. Eight Veterans and eight CA-DRE researchers gathered to discuss current studies investigating pharmacy service and delivery.

Drs. Bruce Alexander and Jason Egge provided an overview of pharmacy research in the VA to set the scene for the evening's program. Next Dr. Brian Lund presented his work on TAPPS, a pharmacy algorithm designed to help pharmacists triage the day's patients. Erin Madsen, a Veteran in the group with computer expertise, provided suggestions for programming the software to track workflow.

Dr. Dan Livorsi presented his proposed Career Development Award (CDA). Dr. Livorsi's presentation asked

Veteran panelists to consider how patients can advocate for antibiotic stewardship. Veteran panelists confirmed the dilemma in balancing patients' expectation for antibiotics with doctors' knowledge of appropriate treatment and/or stewardship.

Response to the meeting was positive. However, both Veterans and Investigators expressed interest in delving into studies that were earlier in the development phase.

Our June 13 meeting agenda includes workshopping Dr. Katherine Hadlandsmyth's focus group instrument for her CDA proposal.


