



Notable VHA History (1920s to 2000s)

- Reported first findings for malaria and long-term health effects of chemical warfare
- Developed and tested effective TB therapies
- Developed first rehab program for blind persons
- Performed the first successful liver transplant
- Linked smoking with cancer of the respiratory tract and lung
- Identified genes for schizophrenia, dementia, laryngeal cancer, Werner's syndrome and Alzheimer's.
- Developed Prolonged Exposure behavioral therapy for PTSD
- Developed the nicotine patch to support smoking cessation
- Developed computer controlled ventilator
- **Veteran Engagement in Research!!!**

The Veterans Health Administration (VHA)

The Office of the Under Secretary for Health (USH) is responsible for the leadership and direction of VHA, the Nation's largest integrated health care system.

The four statutory missions of VHA are:

1. to develop, maintain, and operate a national health care delivery system for eligible Veterans;
2. to administer a program of education and training for health care personnel;
3. **to conduct health care research;** and
4. provide contingency support for DoD and Department of Health and Human Services (HHS) during times of war or national emergency.




VAPORHCS Institutional Review Board (IRB)

Human Research Protection Program (HRPP) and Federal Wide Assurance (FWA)

- The systematic and comprehensive approach of an organization, to ensure human subject protection in all human research conducted under the auspices of the institution.
- The VAPORHCS's HRPP is established in the Medical Center Memorandum No. 151-01, "Responsible Conduct of Research at the VA Medical Center."
- Office of Human Research Protections (OHRP) mandates that each institution's IRB be registered with the OHRP.
- Our VAPORHCS IRB operates under an OHRP approved Federal Wide Assurance (FWA).
- Must be compliant with the terms set forth in the FWA for protecting human subjects and renew this FWA every **three years**.

VAPORHCS Research Pathway

[IRB Handbook & Forms outline the rules for submission](#)

To gain approval:

- 1) Primary Investigator gets funded; hires and trains team
- 2) Research Coordinator compiles Institutional Review Board (IRB) submission; reviews with research team
- 3) Research Coordinator submits PPQ, IRQ and then CRQ
- 4) IRB analyst reviews submission and works with study team to perfect the documents
- 5) Submission is either sent to IRB for review or is given expedited review (outside of IRB) because of "risk" level
- 6) Review from the Information and Security Officer
- 7) Review by Privacy Officer (if IRQ or PRAF)
- 8) Review by Research and Development (R&D) Committee
- 9) Review by ACOS for research
- 10) Approval letter from IRB
- 11) Approval letter from R & D
- 12) Continual Review as necessary

Mental Illness Research, Education and Clinical Centers (MIRECC)

The Mental Illness Research, Education and Clinical Centers (MIRECC) were established by Congress with the goal of researching the causes and treatments of mental disorders and using education to put new knowledge into routine clinical practice in the VA. Specialized mental health centers of excellence (MH CoE) are an essential component of VA's response to meeting the mental health needs of Veterans.
