The other 2 articles (are also attached) include an assessment of breast cancer risk perception among women veterans and a pilot study of pregnancy outcomes among women veterans using the VA. SF	Another thing to consider for the future would be whether to include the Impact Factor of journals in the table showing all articles. I have mixed feelings about this, because there are questions about how these impact factors are calculated. But, the reason I raise it is because there had been concern about whether research on women veterans is appearing in less visible journals, and it could be interesting to know whether this is starting to improve.	We decided not to include the impact factor of the journal to avoid the politics of publications.
SF	I notice that in some places in the document, important limitations of a study are mentioned, along with the findings. I thought they way you did that was effective. If anything, I would like to see that even more (or even having a limitations column in the Table), because of the concern that people who read this will cite conclusions of studies without understanding the caveats. However, in addition to being more work than is feasible at this point, that would make the report long and cumbersome. One idea might be to comment briefly on this issue early in the document, i.e., that each study has to be interpreted subject to limitations and it is not feasible to include all the caveats and limitations in this document, so before citing the findings the reader should refer to the source article.
